I - WAGERING IN COMMON POOL ON SOUTH AFRICA RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in South Africa are:

Bets	Rate of the proportional take-out on stakes in France
	20 %
	25 %
	25 %

- Dividends are rounded down to the lowest decimal.

- For the different bets type proposed in common pool comingled by South Africa, the minimum dividend applied in France is 1,10 €.

1. General provisions

The hand-out pool rules apply for dividends calculation.

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

"Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

The provisions of Article 3 of this Chapter do not apply to "Simple International" bets on South Africa races.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In the case of a dead heat finish in a race, if there is no stake on one of the payable horses, the fraction of the hand-out pool allocated to this horse is set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralized in France is added to the hand-out pool of the next "Simple Gagnant International" bet comingled with South Africa.

All "Simple Gagnant International" bets are refunded when there is no stake placed on either of the horses classified first.

3. "Couplé Ordre International" bet

The "Couplé Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In accordance with the provisions of Title III Ter Chapter 3 of the PMU Online Bets and Games Rules to which "Couplé Ordre International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Couplé Ordre International" bets on South Africa races.

All "Couplé Ordre International" bets are refunded when:

- The number of horses having run in the race is lower than two.
- Fewer than two horses are classified at the finish of the race.
- There is no stake placed on the or all the payable permutations.

4. "Trio Ordre International" bet

The "Trio Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than three.

In accordance with the provisions of Title III Ter Chapter 4 of the PMU Online Bets and Games Rules to which "Trio Ordre International" bets are subjected, the following provisions shall apply:

- The provisions of Article 2 of this Chapter do not apply to "Trio Ordre International" bets on South Africa races.

- In the event of a dead heat finish in a race, a dividend is calculated for each payable permutation and if there are no bets on one of the payable combinations, the fraction of the hand-out pool corresponding to that combination is set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralized in France is added to the hand-out pool of the next "Trio Ordre International" bet comingled with South Africa.

All "Trio Ordre International" bets are refunded when:

- The number of horses having run in the race is lower than three.
- Fewer than three horses are classified at the finish of the race.
- There is no stake placed on the or all the payable permutations.

II – WAGERING IN COMMON POOL ON AUSTRALIAN RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in Australia are:

Bets	Rate of the proportional take-out on stakes in France
	14,50 %
	14,25 %

- Dividends are rounded down to the lowest decimal, except in case of minimum dividend.
- For the different bet types proposed in common pool comingled by Australia, the minimum dividend applied in France is:
 - 1,04 € when the calculated dividend is upper than 1,00 € and lower than 1,10 €;
 - 1,01 € when the calculated dividend is lower than or equal to 1,00 €. In this case, for the "Simple Placé International" bet, payment is made by successive amputation of the aforementioned deductions then from parts of the hand-out pool allocated to the calculations of the other dividends of the same bet.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

The hand-out pool rules apply for dividends calculation.

Provisions of Article 2 of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules apply to "Simple International" bets on australian races.

2. "Simple International" bet

In accordance with the provisions of Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple Gagnant International" bets on australian races.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In the case of a dead heat finish in a race, if there is no stake on one of the payable horses, the fraction of the hand-out pool allocated to this horse is shared out in equal parts among the other horses classified first.

All "Simple Gagnant International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than two.

"Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than five.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first two places when four to seven horses effectively starting in the race, or one of the first three places in the races when eight horses or more effectively starting in the race.

The number of paid places specified above is established in Australia according to the number of horses remaining runners at the moment of the "Deadline for scratching", i.e the day of the races at 07:45 am local Australian time of the organizing racetrack.

However, for races with eight horses or more remaining runners at the moment of the "Deadline for scratching", if the number of horses effectively starting in the race is equal to five, then a "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first two places.

If there is no stake on one of the payable horses, the share-out allocated to that horse is shared out equally among the other payable horses.

All "Simple Placé International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than five.

III – WAGERING IN COMMON POOL ON AMERICAN RACES IN CALIFORNIA STATE

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in State of California are:

Bets	Rate of the proportional take-out on stakes in France
	15,43 %
	15,43 %
	22,68 %
	22,68 %

- Dividends are rounded down to the lowest decimal.

- For the different bets type proposed in common pool comingled by State of California, the minimum dividend applied in France is 1,05 €.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple Gagnant International" bets on California State races.

- The hand-out pool rules apply for "Simple Gagnant International" dividends calculation in case of normal finish and the share-out profit rules apply for "Simple Gagnant International" dividends calculation in case of dead heat finish and for "Simple Placé International" dividends calculation.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In the case of a dead heat finish in a race, if there is no stake on one of the payable horses, the fraction of the hand-out pool allocated to this horse is shared out in equal parts among the other horses classified first.

All "Simple Gagnant International" bets are refunded when there is no stake placed on either of the horses classified first.

- "Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than five.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected is one of the first three placed horses.

If there is no stake on one of the payable horses, the share-out allocated to that horse is shared out equally among the other payable horses.

All "Simple Placé International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than five.

3. "Couplé Ordre International" bet

The "Couplé Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In accordance with the provisions of Title III Ter Chapter 3 of the PMU Online Bets and Games Rules to which "Couplé Ordre International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Couplé Ordre International" bets on California State races.
 - The hand-out pool rules apply for "Couplé Ordre International" dividends calculation in case of normal finish and the share-out profit rules apply for "Couplé Ordre International" dividends calculation in case of dead heat finish.
 - In the case of a dead heat finish in a race, if there are no stake on one of the payable combinations, the fraction of the share-out profit corresponding to that combination is shared out equally among the other payable combinations.
 - If there is no stake in the right order of finish on the combination of the horses classified first and second, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter with any one of the horses having run in the race and the combinations involving the horse classified second and selected in second place by the punter with any one of the horses having run in the race.
- Failing that, all "Couplé Ordre International" bets are refunded.

All "Couplé Ordre International" bets are refunded when:

- The number of horses having run in the race is lower than two.
- Fewer than two horses are classified at the finish of the race.

4. "Trio Ordre International" bet

The "Trio Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than four.

In accordance with the provisions of Title III Ter Chapter 4 of the PMU Online Bets and Games Rules to which "Trio Ordre International" bets are subjected, the following provisions shall apply:

- The provisions of Article 2 of this Chapter do not apply to "Trio Ordre International" bets on California State races.
 - The hand-out pool rules apply for "Trio Ordre International" dividends calculation in case of normal finish and the share-out profit rules apply for "Trio Ordre International" dividends calculation in case of dead heat finish.
 - In the event of a dead heat finish in a race, if there are no stake on one of the payable combinations, the fraction of the share-out profit corresponding to that combination is shared out equally among the other payable combinations.
 - If there is no stake in the right order of finish on the combination of the horses classified first, second and third, or when only two horses are classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter, the horse classified second and selected in second place by the punter, and any one of the horses having run in the race.
- Failing that, or if only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter with any two of the horses having run in the race.
- Failing that, all "Trio Ordre International" bets are refunded.

All "Trio Ordre International" bets are refunded when the number of horses having run in the race is lower than four.

IV – WAGERING IN COMMON POOL ON AMERICAN RACES IN KENTUCKY STATE

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in State of Kentucky are:

Bets	Rate of the proportional take-out on stakes in France
	16 %
	16 %
	19,50 %
	22 %

- Dividends are rounded down to the lowest decimal.

- For the different bets type proposed in common pool comingled by State of Kentucky, the minimum dividend applied in France is 1,05 €.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

All bets are refunded when no horse is classified at the finish of the race.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of article 3 of this Chapter do not apply to "Simple Gagnant International" bets on Kentucky State races.

- The hand-out pool rules apply for "Simple Gagnant International" dividends calculation in case of normal finish and the share-out profit rules apply for "Simple Gagnant International" dividends calculation in case of dead heat finish and for "Simple Placé International" dividends calculation.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than four.

In the case of a dead heat finish in a race, if there is no stake on one of the payable horses, the fraction of the hand-out pool allocated to this horse is shared out in equal parts among the other horses classified first.

If there is no stake on the horse or all horses classified first, the hand-out pool is shared among the horse or all horses classified second.

Failing that, the hand-out pool is shared among the horse or all the horses classified third.

Failing that, all "Simple Gagnant International" bets are refunded.

Under decision of the Stewards, all "Simple Gagnant International" bets may be refunded when the number of horses having run in the race is lower than four.

- "Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than six.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected is one of the first three placed horses.

If there is no stake on one of the payable horses, the share-out allocated to that horse is shared out equally among the other payable horses.

If there is no stake on all horses classified first, second and third.

Failing that, the hand-out pool is shared among the horse or all the horses classified fourth.

Failing that, all "Simple Placé International" bets are refunded.

Under decision of the Stewards, all "Simple Placé International" bets may be refunded when the number of horses having run in the race is lower than six.

3. "Couplé Ordre International" bet

The "Couplé Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than four.

In accordance with the provisions of Title III Ter Chapter 3 of the PMU Online Bets and Games Rules to which "Couplé Ordre International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Couplé Ordre International" bets on Kentucky State races.

- The hand-out pool rules apply for "Couplé Ordre International" dividends calculation in case of normal finish and the share-out profit rules apply for "Couplé Ordre International" dividends calculation in case of dead heat finish.

- In the case of a dead heat finish in a race, if there are no stake on one of the payable combinations, the fraction of the share-out profit corresponding to that combination is shared out equally among the other payable combinations.

- If there is no stake in the right order of finish on the combination of the horses classified first and second or if only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter with any one of the horses having run in the race.

Failing that, the hand-out pool is shared among the combinations involving the horse classified second and selected in second place by the punter with any one of the horses having run in the race.

Failing that, all "Couplé Ordre International" bets are refunded.

Under decision of the Stewards, all "Couplé Ordre International" bets may be refunded when the number of horses having run in the race is lower than four.

4. "Trio Ordre International" bet

The "Trio Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than five.

In accordance with the provisions of Title III Ter Chapter 4 of the PMU Online Bets and Games Rules to which "Trio Ordre International" bets are subjected, the following provisions shall apply:

- The provisions of Article 2 of this Chapter do not apply to "Trio Ordre International" bets on Kentucky State races.

- The hand-out pool rules apply for "Trio Ordre International" dividends calculation in case of normal finish and the share-out profit rules apply for "Trio Ordre International" dividends calculation in case of dead heat finish.

- In the event of a dead heat finish in a race, if there are no stake on one of the payable combinations, the fraction of the share-out profit corresponding to that combination is shared out equally among the other payable combinations.

- If there is no stake in the right order of finish on the combination of the horses classified first, second and third, or when only two horses are classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter, the horse classified second and selected in second place by the punter, and any one of the horses having run in the race.

Failing that, or if only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter with any two of the horses having run in the race.

Failing that, all "Trio Ordre International" bets are refunded.

All "Trio Ordre International" bets are refunded when the number of horses having run in the race is lower than five.

V – WAGERING IN COMMON POOL ON AMERICAN RACES IN NEW YORK STATE

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in New York State are:

Bets	Rate of the proportional take-out on stakes in France
	18 %
	18 %

- Dividends are rounded down to the lowest decimal.
- For the different bets type proposed in common pool comingled by New York State, the minimum dividend applied in France is 1,10 €.

1. General provisions

The share-out pool rules apply for dividends calculation.

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

From the display on the racecourse of the official arrival, the result of the race is definitive as regards the execution of bets even if afterward certain horses came to be downgraded.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules) to which "Simple International" bets are subjected, the following provisions apply:

The provisions of Article 3 of this Chapter do not apply to "Simple Gagnant International" bets on New York State races.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

When several horses have been classified first in a race and no stake has been placed on one of these horses, the fraction of the share-out allocated to this horse is shared out in equal parts among the other horses classified first.

All "Simple Gagnant International" bets are refunded when:

- The number of horses having run in the race is lower than two.
- There is no stake placed on either of the horses classified first.

- "Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than eight.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected is one of the first three placed horses.

If no bets have been placed on one of the payable horses, the share-out allocated to that horse is shared out equally among the other payable horses.

All "Simple Placé International" bets are refunded when:

- The number of horses having run in the race is lower than five.
- There is no stake placed on any payable horses.

VI – WAGERING IN COMMON POOL ON BRITISH RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in Great Britain are:

Bets	Rate of the proportional take-out on stakes in France
	19,25 %
	20 %
	25 %
	25 %

- Dividends are rounded down to the lowest decimal, except in case of minimum dividend.

- For the different bet types proposed in common pool comingled by Great Britain, the minimum dividend applied in France is 1,10 € except in the following cases:

- For the "Simple Gagnant International" bet:
 - In the case of a normal finish, the minimum dividend applied in France is 1,02 € when the calculated dividend is lower than or equal to 0,90 € ;
 - In the case of a dead heat finish, the minimum dividend applied in France is 1,01 € when the calculated dividend is lower than or equal to 0,60 €.
- For the "Simple Placé International" bet:
 - In the case of a normal finish, the minimum dividend applied in France is 1,02 € when the calculated dividend is lower than or equal to 0,70 €. In this case, the calculated dividend concerned is increased to 0,70 € by amputation from parts of the hand-out pool allocated to the calculations of the other dividends.
 - In the case of a dead heat finish, the minimum dividend applied in France is 1,01 € when the calculated dividend is lower than or equal to 0,50 €.
- For the "Couplé Ordre International" bet and the "Trio Ordre International" bets:
 - In the case of a dead heat finish, the minimum dividend applied in France is 1,01 € when the calculated dividend is lower than or equal to 0,60 €.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

All bets are refunded when no horse is classified at the finish.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple International" bets on british races.
- The hand-out pool rules apply for dividends calculation.

- **"Simple Gagnant International" bet**

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In the case of a dead heat finish in a race, if there is no stake on one of the payable horses, the fraction of the hand-out pool allocated to this horse is set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Simple Gagnant International" bet comingled with Great Britain.

- If the total winning stakes are less than the minimum stake mentioned in article 10 of Title II Chapter 2 of the PMU Online Bets and Games Rules and wagered in France, the corresponding dividend is weighted in a proportion equal to the quotient resulting from the division of the total winning stakes for the dividend in question by the minimum stake mentioned in Article 10 aforementioned for this bet.

The undistributed fraction of the hand-out pool is then set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Simple Gagnant International" comingled with Great Britain.

All "Simple Gagnant International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than two.

"Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than five, except on handicap races with more than fifteen runners.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first two places when four to seven horses effectively starting in the race, or one of the first three places in the races when eight horses or more effectively starting in the race.

If there is no stake on one of the payable horses, the share-out allocated to that horse is shared out equally among the other payable horses of wich winning stakes are upper than minimum stake.

- If the total winning stakes on one of the payables horses are less than the minimum stake mentioned in Article 10 of Title II Chapter 2 of the PMU Online Bets and Games Rules and wagered in France, the corresponding dividend is weighted in a proportion equal to the quotient resulting from the division of the total winning stakes for the dividend in question by the minimum stake mentioned in Article 10 aforementioned for this bet.

The undistributed fraction of the hand-out pool is then set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Simple Placé International" comingled with Great Britain.

All "Simple Placé International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than five.

3. "Couplé Ordre International" bet

The "Couplé Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than three.

In accordance with the provisions of Title III Ter Chapter 3 of the PMU Online Bets and Games Rules to which "Couplé Ordre International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Couplé Ordre International" bets on british races.
- The hand-out pool rules apply for dividends calculation.

If only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first with any one of the horses having run in the race.

All "Couplé Ordre International" bets are refunded when:

- There is no stake placed on the or all the payable permutations.
- The number of horses having run in the race is lower than three.

4. "Trio Ordre International" bet

The "Trio Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than three.

In accordance with the provisions of Title III Ter Chapter 4 of the PMU Online Bets and Games Rules) to which "Trio Ordre International" bets are subjected, the following provisions shall apply:

- The provisions of Article 2 of this Chapter do not apply to "Trio Ordre International" bets on british races.
- The hand-out pool rules apply for dividends calculation.
- In the event of a dead heat finish in a race, if there are no stake on one of the payable combinations, the fraction of the hand-out pool corresponding to that combination is set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Trio Ordre International" bet comingled with Great Britain.
- When only two horses are classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter, the horse classified second and selected in second place by the punter, and any one of the horses having run in the race. Failing that, all "Trio Ordre International" bets are refunded.
- If only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter with any two of the horses having run in the race. Failing that, all "Trio Ordre International" bets are refunded.

All "Trio Ordre International" bets are refunded when:

- There is no stake placed on the or all the payable permutations.
- The number of horses having run in the race is lower than three.

VII – WAGERING IN COMMON POOL ON HONG KONG RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in Hong Kong are:

	17,50 %
	17,50 %

- Dividends are rounded to the nearest 5 cents, except in case of "Simple Placé International" minimum dividend.

- For the different bet types proposed in common pool comingled by Hong Kong, the minimum dividend applied is:

- 1,05 € for "Simple Gagnant International" ;
- 1,01 € for "Simple Placé International".

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded. The hand-out pool rules apply for dividends calculation.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple International" bets on Hong Kong races.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

When several horses have been classified first in a race and no bet has been placed on one of these horses, the fraction of the hand-out pool allocated to this horse is shared out in equal parts among the other horses classified first.

If there is no stake on the horse or all horses classified first, the hand-out pool is shared among the horse or all horses classified second.

Failing that, the hand-out pool is shared among the horse or all the horses classified third.

Failing that, all "Simple Gagnant International" bets are refunded.

All "Simple Gagnant International" bets are refunded when the number of horses having run in the race is lower than two.

- "Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than four.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first three places in the races with seven runners or more at the start of the betting operations in Hong Kong or one of the first two places in the races with four to six runners at the start of the betting operations in Hong Kong.

If no bets have been placed on one of the payable horses, the hand-out pool allocated to that horse is shared out in equal parts among the other payable horses.

All "Simple Placé International" bets are refunded if:

- The number of horses having run in the race is lower than five in the races paying three places or lower than four in the races paying two places;
- There is no stake placed on any one of the payable horses for the "Simple Placé International" bet.

VIII – WAGERING IN COMMON POOL ON IRISH RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in Ireland are:

- Dividends are rounded down to the lowest decimal, except in case of minimum dividend.

- For the different bet types proposed in common pool comingled by Ireland, the minimum dividend applied in France is 1,10 € except in the following cases:

- For the "Simple Gagnant International" bet:
 - In the case of a normal finish, the minimum dividend applied in France is 1,02 € when the calculated dividend is lower than or equal to 0,90 € ;
 - In the case of a dead heat finish, the minimum dividend applied in France is 1,01 € when the calculated dividend is lower than or equal to 0,60 €.

- For the "Simple Placé International" bet:
 - In the case of a normal finish, the minimum dividend applied in France is 1,02 € when the calculated dividend is lower than or equal to 0,70 €. In this case, the calculated dividend concerned is increased to 0,70 € by amputation from parts of the hand-out pool allocated to the calculations of the other dividends.
 - In the case of a dead heat finish, the minimum dividend applied in France is 1,01 € when the calculated dividend is lower than or equal to 0,50 €.

- For the "Couplé Ordre International" and the "Trio Ordre International" bets:
 - In the case of a dead heat finish, the minimum dividend applied in France is 1,01 € when the calculated dividend is lower than or equal to 0,60 €.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded.

All bets are refunded when no horse is classified at the finish.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple International" bets on Irish races.
- The hand-out pool rules apply for dividends calculation.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

In the case of a dead heat finish in a race, if there is no stake on one of the payable horses, the fraction of the hand-out pool allocated to this horse is set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Simple Gagnant International" bet comingled with Ireland.

- If the total winning stakes are less than the minimum stake mentioned in Article 10 of Title II Chapter 2 of the PMU Online Bets and Games Rules)and wagered in France, the corresponding dividend is weighted in a proportion equal to the quotient resulting from the division of the total winning stakes for the dividend in question by the minimum stake mentioned in Article 10 aforementioned for this bet.

The undistributed fraction of the hand-out pool is then set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Simple Gagnant International" comingled with Ireland.

All "Simple Gagnant International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than two.

"Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than five, except on handicap races with more than fifteen runners.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first two places when four to seven horses effectively starting in the race, or one of the first three places in the races when eight horses or more effectively starting in the race.

If there is no stake on one of the payable horses, the share-out allocated to that horse is shared out equally among the other payable horses of wich winning stakes are upper than minimum stake.

- If the total winning stakes on one of the payables horses are less than the minimum stake mentioned in Article 10 of Title II Chapter 2 of the PMU Online Bets and Games Rules and wagered in France, the corresponding dividend is weighted in a proportion equal to the quotient resulting from the division of the total winning stakes for the dividend in question by the minimum stake mentioned in Article 10 aforementioned for this bet.

The undistributed fraction of the hand-out pool is then set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Simple Placé International" comingled with Ireland.

All "Simple Placé International" bets are refunded when:

- There is no stake placed on any payable horses.
- The number of horses having run in the race is lower than five.

3. "Couplé Ordre International" bet

The "Couplé Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than three.

In accordance with the provisions of Title III Ter Chapter 3 of the PMU Online Bets and Games Rules to which "Couplé Ordre International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Couplé Ordre International" bets on irish races.
- The hand-out pool rules apply for dividends calculation.

If only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first with any one of the horses having run in the race.

All "Couplé Ordre International" bets are refunded when:

- There is no stake placed on the or all the payable permutations.
- The number of horses having run in the race is lower than three.

4. "Trio Ordre International" bet

The "Trio Ordre International" bet may be proposed on all races involving a number of runners equal to or upper than three.

In accordance with the provisions of Title III Ter Chapter 4 of the PMU Online Bets and Games Rules to which "Trio Ordre International" bets are subjected, the following provisions shall apply:

- The provisions of Article 2 of this Chapter do not apply to "Trio Ordre International" bets on irish races.
- The hand-out pool rules apply for dividends calculation.
- In the event of a dead heat finish in a race, if there are no stake on one of the payable combinations, the fraction of the hand-out pool corresponding to that combination is set aside to constitute a jackpot. The part of this jackpot made up of the stakes centralised in France is added to the hand-out pool of the next "Trio Ordre International" bet comingled with Ireland.
- When only two horses are classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter, the horse classified second and selected in second place by the punter, and any one of the horses having run in the race. Failing that, all "Trio Ordre International" bets are refunded.
- If only one horse is classified at the finish of the race, the hand-out pool is shared among the combinations involving the horse classified first and selected in first place by the punter with any two of the horses having run in the race. Failing that, all "Trio Ordre International" bets are refunded.

All "Trio Ordre International" bets are refunded when:

- There is no stake placed on the or all the payable permutations.
- The number of horses having run in the race is lower than three.

IX – WAGERING IN COMMON POOL ON NORWEGIAN RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in Norway are:

 Simple Gagnant International	20 %
 Simple Placé International	20 %

- Dividends are rounded down to the lowest decimal.

- For the different bet types proposed in common pool comingled by Norway, the minimum dividend applied is 1.10 €.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded. However, this provision does not apply for finals of elimination races. In this case, if a horse does not run in the final race, bets wagered on this horse are not refund.

2. "Simple International" bet

In accordance with the provisions Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple International" bets on Norwegian races.

- The hand-out rules apply for "Simple Gagnant International" dividend calculations. The share-out profit rules apply for "Simple Placé International" dividend calculations.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

When several horses have been classified first in a race and no bet has been placed on one of these horses, the fraction of the hand-out pool allocated to this horse is shared out in equal parts among the other horses classified first.

All "Simple Gagnant International" bets are refunded when:

- The number of horses having run in the race is lower than two.
- There is no stake placed on either of the horses classified first.

- "Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than four.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first three places, in the races involving seven horses or more appearing on the official racecard, or one of the first two places in the races involving four to six horses appearing on the official racecard.

In the case of a dead-heat finish, the share-out profit is divided into as many equal parts as there are placed payable horses. Each of these parts is thereafter shared out in proportion to the winning stakes on each of these horses. The quotients thus obtained, plus the unit stake, constitute the gross dividends for each of the payable horses

If no bets have been placed on one of the payable horses, the share-out profit allocated to that horse is shared out in equal parts among the other payable horses.

All "Simple Placé International" bets are refunded if:

- The number of horses having run in the race is lower than four.
- There is no stake placed on any one of the payable horses for the "Simple Placé International" bet.

X – WAGERING IN COMMON POOL ON SWEDISH RACES

In accordance with the provisions of Title III Ter Chapter 1 of the PMU Online Bets and Games Rules:

- The rates of the proportional take-out on stakes applied to each bet type in force in Sweden are:

Bets	Rate of the proportional take out on stakes in France
 Simple Gagnant International	15 %
 Simple Placé International	15 %

- Dividends are rounded down to the lowest decimal.

- For the different bet types proposed in common pool comingled by Sweden, the minimum dividend applied is 1.10 €.

1. General provisions

Bets wagered on combinations in which at least one of the horses is a non-runner are refunded. However, this provision does not apply for finals of elimination races. In this case, if a horse does not run in the final race, bets wagered on this horse are not refund.

2. "Simple International" bet

In accordance with the provisions of Title III Ter Chapter 2 of the PMU Online Bets and Games Rules to which "Simple International" bets are subjected, the following provisions apply:

- The provisions of Article 3 of this Chapter do not apply to "Simple International" bets on Swedish races.

- The hand-out rules apply for "Simple Gagnant International" dividend calculations. The share-out profit rules apply for "Simple Placé International" dividend calculations.

- "Simple Gagnant International" bet

The "Simple Gagnant International" bet may be proposed on all races involving a number of runners equal to or upper than two.

When several horses have been classified first in a race and no bet has been placed on one of these horses, the fraction of the hand-out pool allocated to this horse is shared out in equal parts among the other horses classified first.

All "Simple Gagnant International" bets are refunded when:

- The number of horses having run in the race is lower than two.
- There is no stake placed on either of the horses classified first.

- "Simple Placé International" bet

The "Simple Placé International" bet may be proposed on all races involving a number of runners equal to or upper than four.

A "Simple Placé International" bet is awarded a "Simple Placé International" dividend if the horse selected occupies one of the first three places, in the races involving seven horses or more appearing on the official racecard, or one of the first two places in the races involving four to six horses appearing on the official racecard.

In the case of a dead-heat finish, the share-out profit is divided into as many equal parts as there are placed payable horses. Each of these parts is thereafter shared out in proportion to the winning stakes on each of these horses. The quotients thus obtained, plus the unit stake, constitute the gross dividends for each of the payable horses

If no bets have been placed on one of the payable horses, the share-out profit allocated to that horse is shared out in equal parts among the other payable horses.

All "Simple Placé International" bets are refunded if:

- The number of horses having run in the race is lower than four.
- There is no stake placed on any one of the payable horses for the "Simple Placé International" bet.
